### 4. First-Aid Measures

#### **Description of first aid measures**

#### General advice:

First aid personnel should pay attention to their own safety. If the patient is likely to become unconscious, place and transport in stable sideways position (recovery position). Immediately remove contaminated clothing.

#### If inhaled:

Remove the affected individual into fresh air and keep the person calm. Assist in breathing if necessary.

#### If on skin:

Rinse skin immediately with plenty of water for 15 - 20 minutes.

#### If in eyes:

Hold eyes open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after first 5 minutes, then continue rinsing.

#### If swallowed:

Rinse mouth and then drink 200-300 ml of water. Do not induce vomiting. Never induce vomiting or give anything by mouth if the victim is unconscious or having convulsions. Immediate medical attention required.

# Personal precautions, protective equipment and emergency procedures

# **Environmental precautions**

#### Methods and material for containment and cleaning up

Dike spillage. Pick up with suitable absorbent material. Place into suitable containers for reuse or disposal in a licensed facility. If application of spilled substance/product is not possible, then spills should be contained, solidified, and placed in suitable containers for disposal. # 7. Handling and Storage
